Prize Draw Giveaway Terms and Conditions:

Parties

- **Aon** – Aon New Zealand, also referred to as **we/us/our**.
- **You** – the person who enters the prize draw.

The Opportunity

1. There are two prizes available. All eligible persons may go in the draw to win **one (1)** of the **two (2)** prizes. Each prize is a Voyage for a child aged between 16-19 (inclusive) aboard the Spirit of New Zealand, operated by the Spirit of Adventure Trust.
2. The Voyage is Voyage #946 aboard the Spirit of New Zealand; which is currently scheduled to depart from Princes Wharf, Corner Quay and Hobson Streets, Auckland at **5:00 p.m. on 24 June 2026** and return at **9:00 a.m. on 4 July 2026**. **However**, the Spirit of Adventure Trust may at its discretion, cancel, advance, postpone or substitute any scheduled sailing at any time.
3. The value of each prize as advertised by the Spirit of Adventure Trust is \$2,995 (including GST).
4. **Please Note:** participating in the Voyage is subject to any requirements or conditions that may be imposed by the Spirit of Adventure Trust from time to time. Receipt of the prize is conditional on **your** child meeting all requirements of the Spirit of Adventure Trust to participate in the Voyage. If these requirements are not met, your child will not be able to receive the prize and participate in the Voyage. **We** strongly encourage **you** to review the Spirit of Adventure Trust's Terms and Conditions, as well as its Health, Fitness, and Dietary Requirements **before** submitting **your** entry into the draw. Eligibility

5. Individuals will only have one opportunity to enter the draw.
6. To be eligible to enter the draw, **you** must:
 - a. be a New Zealand resident and be the parent or guardian of a child between the ages of **16-19** years (inclusive) who is resident in New Zealand; and
 - b. complete and submit the online entry form in full via the Aon website within the Submission Period (see clause 9 below).
7. **We** will disregard and exclude from the draw, any or all of the following kinds of submission:

- a. duplicate submissions.
- b. submissions received following closure of the Submission Period.
- c. submissions that are illegible, incomplete, or inaccurate.
- 8. No purchase is required and there is no cost to enter the draw.
- 9. The Submission Period to enter the draw opens at **10:00 a.m. on 26 November 2025** and closes at **5:00 p.m. on 31st March 2026**.
- 10. **We** reserve the right to verify **you** and/or **your** child's identity, eligibility or other qualifying factors as a pre-condition to awarding or confirming **your** prize.
- 11. Any decision **we** make to exclude a submission from the draw is final; and **we** will not entertain any correspondence on the subject.

Winner Selection

- 12. **We** will randomly draw the entry forms of two (2) entrants from the pool of all eligible entrants on **1 April 2026**. The two entrants selected will each win one (1) of the prizes.
- 13. If **you** win a prize:
 - a. **you** will be notified on **2 April 2026**;
 - b. **we** will **introduce you** and **your** child to the Spirit of Adventure Trust.
 - c. it is **your** responsibility to at **your cost and expense**:
 - i. ensure that **your** child arrives at the departure location of the ship on the scheduled departure date notified to **you**; and
 - ii. co-ordinate with the Spirit of Adventure Trust to ensure that **your** child satisfies their health and fitness requirements, and/or any other terms and conditions as they deem fit.
- 14. **We** reserve the right to revoke the prize and randomly draw a replacement winner from the remaining eligible entrants if:
 - a. we are unable to verify **you** and/or **your** child's eligibility under these Terms and Conditions;
 - b. after making reasonable efforts, **we** have not been able to contact **you**, and **your** prize remains unclaimed;
 - c. the Spirit of Adventure Trust advises **us** that it has, in its sole discretion, judged that **your** child does not meet their requirements for participation in the Voyage;
 - d. **your** child is unable to, **at your sole cost and expense**, meet at Princes Wharf, Corner Quay and Hobson Streets, Auckland by no later than **2:00 p.m. on 24 June 2026** or such other date/time notified to **you** by the Spirit of Adventure Trust; or
 - e. **you** or **your** child breaches or do not comply with these Terms and Conditions.
- 15. Any decision **we** make is final, and **we** will not entertain any correspondence on the subject.

Media

16. If **your** child participates in the Voyage:
 - a. **We** will work with the Spirit of Adventure Trust crew to capture media content including but not limited to photos, and videos of **your** child before, during, and after the Voyage.
 - b. **We** may contact **your** child before, during, and after the Voyage to create content including but not limited to interviews, photos, videos, quotes, and other material that can be used to promote and leverage **Aon's** relationship with Spirit of Adventure Trust.
17. By submitting **your** entry, **you** confirm that **you** have discussed the above content-gathering with **your** child, who has provided their consent to the content gathering and **you** agree that **your** child will take part in the above content-gathering opportunities upon **our** request or the request of the Spirit of Adventure Trust.
18. Further, **you** agree that the content gathered of **your** child may be used internally and externally to promote and leverage the relationship between **Aon** and the Spirit of Adventure Trust.

You and Your Child's Conduct

19. If **you** win one of the prizes, neither **you** nor **your** child may post any images, videos or comments on any social media site that may give a negative impression of **Aon**, the Spirit of Adventure Trust, Trust crew, or other participants.
20. If **you** win a prize and **your** child is cleared for participation in the Voyage by the Spirit of Adventure Trust **your** child **must**, and **you** will procure that **your** child **must**:
 - a. maintain a high standard of behaviour when traveling to or from the ship and throughout the Voyage;
 - b. **not** bring or use alcohol, illegal drugs, cigarettes (including e-cigarettes, vaping), or any weapons (such as knives) when travelling to or from the ship, or at any time during the Voyage;
 - c. comply with all safety standards and instructions given at any time by the crew;
 - d. respect the crew and other participants;
 - e. refrain from offensive language or threatening behaviour whilst travelling to, from, or aboard the ship.

Privacy

21. **We** will hold, use, and disclose any personal information **you** provide – whether on behalf of **yourself** or **your** child – in accordance with the Privacy Act 2020 and for the purposes of these terms and conditions. **We** will share **your** and **your** child's personal information:

- a. with the Spirit of Adventure Trust who may use the information provided on **your** application to assess **your** child's suitability to participate in the Voyage; or
 - b. where required to do so by law.
- 22. **You** do not have to provide the information that **we** request, but failure to do so may mean that **you** are ineligible to enter the draw and/or **your** child is ineligible to participate in the Voyage.
- 23. If **you** provide information relating to an individual other than **you**, **you** must do the following:
 - a. first ensure that they are aware of the ways in which **we** will collect, use, and disclose their personal information; and
 - b. before providing **us** with their personal information, obtain their consent.
- 24. **We** will hold personal information that **you** provide – whether on behalf of **yourself** or **your** child – in accordance with these Terms and Conditions, and the Privacy Act 2020, at:
 - a. Level 21, Aon Centre, 29 Customs Street West, Auckland 1010 or one of **our** other branches, within New Zealand; or
 - b. in offshore facilities of companies which are part of the global group of companies held by Aon plc (NYSE: AON).
- 25. **You** and **your** child have certain rights of access to and correction of any personal information that **we** hold.

Disclaimer

- 26. To the fullest extent permitted by law **Aon** excludes all liability for costs, charges or expenses, claims, damages and losses incurred in or connected with the Voyage, except where it is caused by **our** negligence. **Your** statutory rights are not affected.

Health, Fitness, and Dietary Requirements

- 27. Without limitation, **you** are advised that:
 - a. the galley aboard the Spirit of New Zealand is such that the Spirit of Adventure Trust **cannot** cater to those with **either coeliac disease or anaphylactic allergies**. Accordingly, **you** are advised **your** child will **not** be able to participate in the Voyage if they have **either** of those conditions.
 - b. the following health conditions **may** mean that **your** child is not able to participate in the Voyage:
 - I. heart conditions.
 - II. epilepsy.
 - III. mental impairment.
 - IV. physical impediment.
 - V. anxiety, depression or anti-social behaviour.

- VI. body weight in excess of 140 kilograms.
